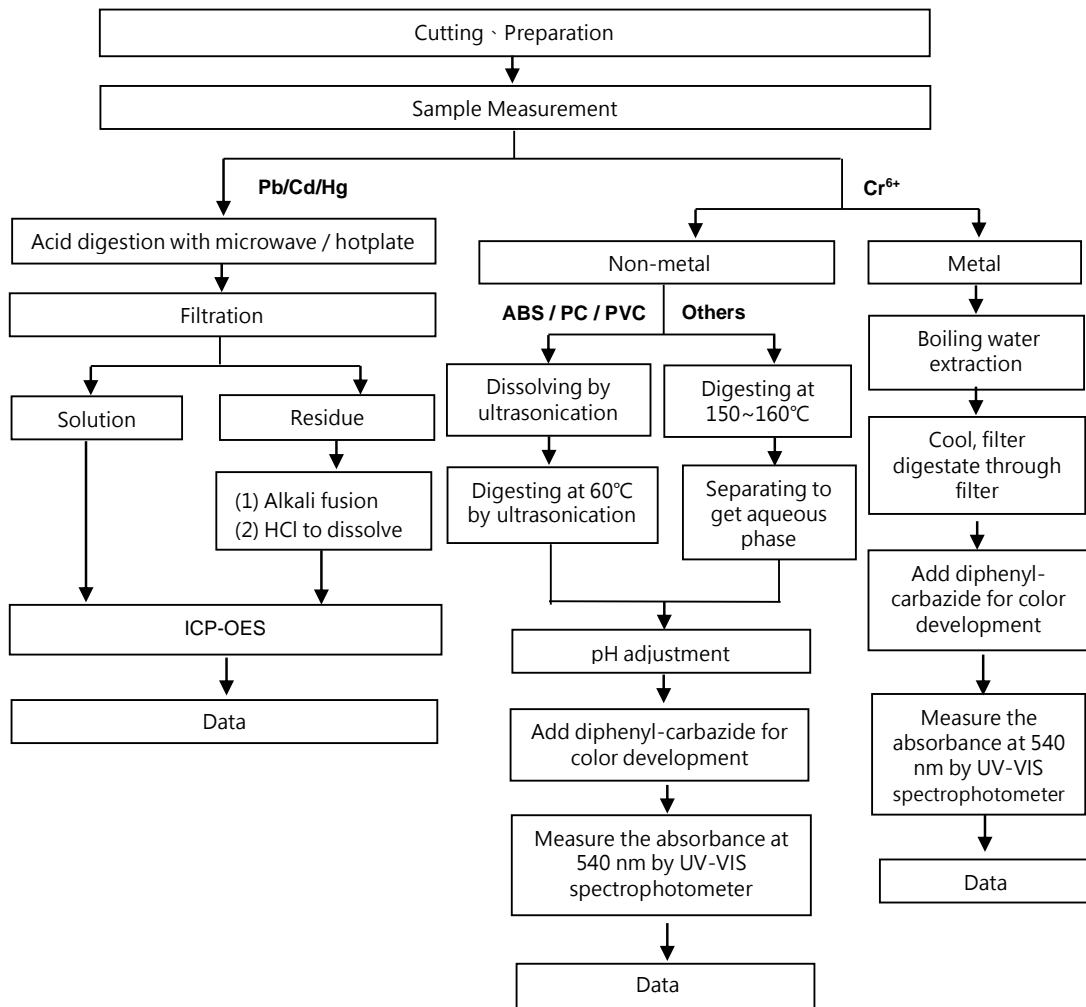

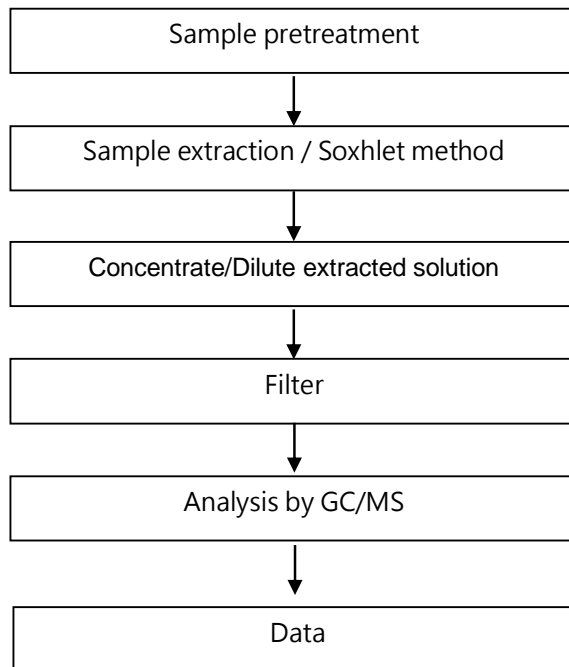
## Analytical flow chart of Heavy Metal

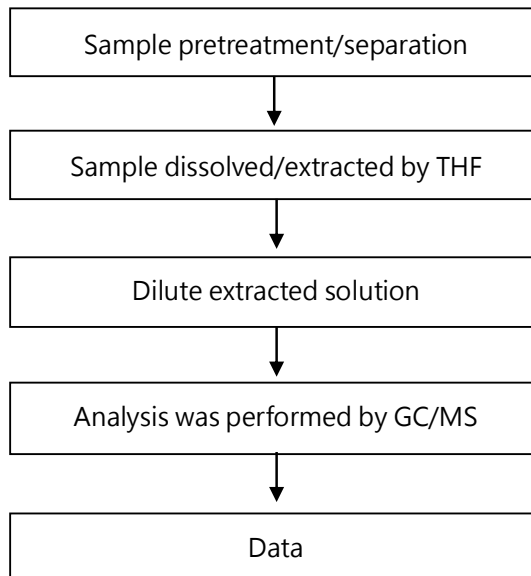
### PBB/PBDE analytical FLOW CHART
